Sub: Release of revised allocation of rice under WI & Hostels (Govt. run/owned/aided/sponsored) Scheme for the 2nd half of 2023-24 (Oct'23 to Mar'24).

Ref: This Department letter No. 14933 Dated 13th September 2023; Letter No. 4-6/2018/Odisha/BP-II, Dated 25th September of DoFPD, Government of India.

Sir,

In continuation to this Department letter No. 14933 Dated 13th September 2023 on the subject cited above, I am directed to inform you that as per the request made, DoFPD, Government of India have released the HY 2023-24 (Oct'2023 to Mar'2024) allocation of rice @9466.620 MT per month under WI & Hostels (Govt. run/owned/aided/sponsored) Scheme in the following manner:

Accordingly, the district-wise sub allocation of the above Government of India allocation has been released and lifting of the same is going on by the four administrative Departments of the State Government.

But, after receipt of communication from the four line Departments of ST & SC Development, SS&EPD, S&ME and W&CDMS regarding non-allotment of rice in favour of some WIs/Hostels, the matter was examined and found that due to some updation related issues in the database of the four Departments, 418 numbers of Welfare Institutions/Hostels covering 34,486 boarders were deprived from their entitlements of rice for the current 2nd HY allocation of 2023-24 (October 2023 to March 2024) translating to 31,037.40 quintals of rice @15 kilograms per boarder per month, for six months. These boarders and institutions exist in the database and have been receiving rice every allocation month. The details of these left-out institutions and number of boarders can be verified from the FS & CW Department web portal in public domain at www.pdsodisha.gov.in

The district-wise 2nd HY 2023-24 sub allocation released earlier in consonance with GoI's allocation is enclosed at Annexure-1. **The district-wise and Department-wise number of 418 Welfare Institutions/Hostels covering 34,486 boarders amounting to 31,037.40 quintals of rice @15 kilograms per boarder per month, for six months is also attached at Annexure-2&3.**

I, would therefore request you to kindly release revised monthly allocation of **9,983.910 MT rice per month** (GoI's earlier released allocation: 9466.620 MT+517.290 MT for the left-out boarders in the WIs/Hostels) for the **2nd half of 2023-24** i.e. Oct-2023 to March-2024 for utilization by the Welfare Institutions/Hostels. The revised requisition for the same is enclosed at **Annexure-4** for kind reference.

Sub: **District-wise allotment of Rice under Welfare Institutions & Hostels Scheme (Government Run/Own & Government Sponsored/Aided) for the 2nd Half of 2023-24, i.e. from Oct'2023 to March'2024.**

Madam/Sir,

I am directed to communicate the district-wise half-yearly allocation of **5,67,997.20 Qtls of FORTIFIED RICE as at Annexure-I & II**, out of Central Pool as per GOI letter No.4-6/2018/Odisha/BP-II(e-366741) dt.25th Sept, 2023 for **6,06,914** residents/boarders residing in the **4,327** Government run/owned and **24,194** residents/boarders residing in the **478** Government aided/sponsored Welfare Institutions/Hostels, for the month from **Oct'2023 to March'2024**, which have been registered in the web portal of the FS & CW Department www.pdsodisha.gov.in through their respective administrative Departments.

The concerned Administrative Departments at district level shall deduct the available balance of rice stocks of preceding allotment months in Welfare Institutions/Hostels (if any) from the allocated quantity and to lift the remaining quantity from the RRC-cum-DSCs of OSCSC Ltd.

The allotment for all Institutions/Hostels has been calculated @ 15 Kgs per boarder per month, for six months. Administrative Departments having Child Care Institutions shall lift & utilise rice @ 8.5 Kgs per boarder per month. Any excess quantity lifted & utilised by the CCIs will be subjected to deduction from the next allotment months.

The issue price of the rice for the Government Run/Owned Institutions is Re. 1/- per Kg. and the issue price of rice for Government Aided/Sponsored Institutions will be at the erstwhile BPL rates or as finalized by the concerned Administrative Departments.

Besides, instructions should also be issued to all CCSOs/CSOs-cum District Managers/DLOs of concerned Administrative Departments to deduct the rice requirement of the Welfare Institutions/Hostels in case of Summer Holidays and rice in actual quantities may be issued.

The quarterly reports/UCs for the preceding months may be submitted to OSCSC Ltd Head Office (if not submitted as per Government of India format circulated earlier) for compilation and submission to FS & CW Department for onward transmission to Government of India.

The institution/hostel-wise sub-allocation of rice may be downloaded from the web portal www.pdsodisha.gov.in under link "**Allotment of Rice under WI & Hostels**". All the District level officers of the concerned Administrative Departments may be requested to adhere to the following lifting schedule without fail.

Allocation for Oct'2023	To be lifted by 25 th Oct'2023
Allocation for Nov'2023	To be lifted by 31 st Oct'2023
Allocation for Dec'2023 to March'2024	To be lifted by end of the month preceding the allotment month.
UC to be submitted to OSCSC Head office.	By 10 th March'2024
